Chief Thompson reported the Department responded to 182 calls for assistance during May. There were three structure fires during the month. Annual hose testing has been completed. Mr. Brakebill was commended for donating his time to instruct a driver operator class. The Twentynine Palms Chamber of Commerce recognized the Twentynine Palms firefighters for their contribution to the community honoring them as

Public Servants of the Year. The City Council agreed to move forward with a joint workshop meeting with the Water District Board of Directors. The meeting is anticipated for some time in September. The Lew Edwards Group is approximately 75% completed with the voter survey.

8. Future Agenda Items and Staff Tasks/Directors' Comments and Reports

Director Chambers commented that he would like to meet with the City and wait for the survey results from the Lew Edwards Group prior to moving forward with an Ordinance and ballot measure. Director Chambers would also like to see how many local paid call firefighters are working and their impact on the department's budget at the November board meeting.
